Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) on the Rs.29.70 Cr. bank facilities of V. P. Muthaiah Pillai Meenakshi Ammal Trust (VPMP). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

VPMP, established in 1993 a Tamil Nadu based Educational Trust by Dr. V.P.M. Sankar (Chairman) and others. The trust has eight institutions with over 6000 students in the campus spread across 200 acres. The day-to-day operations are managed by the Chairman of the trust.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit ratings is based
