Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.8.20 crore bank facilities of Om Dutta Industries(ODI). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Established in the year 2010, Om Dutta Industries (ODI) is a Madhya Pradesh-based partnership firm engaged in the manufacturing of Calcined Petroleum Coke (CPC). The firm is led by partners Mr. Piyush Kaushik and Mrs. Manjula Kaushik. The commercial operations commenced in June 2016. The manufacturing facility is located near Indore, Madhya Pradesh and has an installed capacity of 3000 MT per month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
