Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 29.20 crore bank facilities of Anand Transformers Private Limited (ATPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Anand Transformers Private Limited (ATPL), incorporated in 1988, is a Lucknow (Uttar Pradesh) based company engaged in the manufacture and repair of power transformers. The company started the development of electrical infrastructure such as substations, transmission and distribution lines through joint venture 'Infrastructure Development' from FY2016 onwards. Infrastructure Development is a 47:53 joint venture between ATPL and Navjeet Industries. Navjeet Industries is a Kanpur (Uttar Pradesh) based company engaged in the manufacture of transformers.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
