**Rating Rationale**

Acuite has reaffirmed the long-term rating of **‘ACUITE D’ (read as ACUITE D)** on the Rs. 20.00 crore bank facilities of Singhvi Fashions Private Limited (SFPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Singhvi Fashions Private Limited, incorporated in 2011, is a Surat-based company promoted by Mr. Haresh Rudakiya, Mr. Nitesh V Makrubia, Mr. Prashant Hadiya, Mr. Sunil Patel and Mr. Vishal Sakariy. The company is engaged in processing and trading of grey fabric for the home furnishing industry.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
