Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 26.03 crore bank facilities of Bina Udyog Private Limited (BUPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Established in 2002, Bina Udyog Private Limited (BUPL) is engaged in the manufacture of PP bags used for packaging of commodities such as cement, sugar, chemicals, at Howrah. The company has two units with a combined production capacity of 700 tonnes per month. The day-to-day operations are managed by Mr. Vivek Agarwal and Mr. Vinod Kumar Agarwal, who possess over a decades experience in the aforementioned industry.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
