SMERA has reviewed long-term rating of '**SMERA B**' (read as **SMERA B**) and short term rating of '**SMERA A4**' (read as '**SMERA A four**') on the Rs. 6.95 crore bank facilities of PLATO INDUSTRIES LIMITED. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower

The company caters to Bharat Broadband Network, Bharat Sanchar Nigam Limited, Bharti Airtel to name a few.
