Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.95 crore bank facilities of Plato Industries Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk .

About the Company

Plato Industries Limited was incorporated on 14th February, 1992 at Parwanoo (Himachal Pradesh). The company is engaged in the manufacture of HDPE pipe, telecom ducts, MDPE pipes, duct pipes and sprinklers and has an installed capacity of 2200 tonnes per annum. Deepak Thakur, Anurag Bhanot, Suman Sharma are the directors of the company. The company caters to Bharat Broadband Network, Bharat Sanchar Nigam Limited and Bharti Airtel, to name a few.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
