Acuité has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) the Rs.9.00 crore bank facilities of Annai Arul Healthcare Private Limited. This rating is now an indicative rating and is based on best available information.

AAHPL, incorporated in 2012 was promoted by Dr. Joseph Jensingh Babu and Mr. Antony Christopher Joseph. The company runs Annai Arul Hospital, an 87-bed multi-speciality hospital in Chennai.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
