Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 29.20 crore bank facilities of Durlax Archtech Private Limited (DAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

DAPL, incorporated in 2010, is a Mumbai-based company promoted by Mr. Shravan Suthar, Mr. Amit Vyas, Mr. Laxmichand L. Suthar that trades in decorative solid sheets and adhesives used in seamless countertop installations in the kitchen, exterior building façades, wall cladding among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
