Acuité has downgraded the long term rating to '**ACUITE B+**' (**read as ACUITE B plus**) from '**ACUITE BB-**' (**read as ACUITE double B minus**) and the short term rating to '**ACUITE A4**' (**read as ACUITE A four**) from '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs.9.44 crore bank facilities of Nikita Jewellery Private Limited (NJPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

NJPL, incorporated in 2002, is a Mumbai-based company promoted by Mr. Ashok Kumar Daga, Mr. Abhinav Kumar Daga and Mrs. Sushila Kumari Daga. The company is engaged in the manufacture and export of jewellery (gold, silver, and diamonds) at Mumbai. The products include rings, earrings, pendants and bracelets.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
