Acuité has reviewed the long term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 14.00 crore bank facilities of Raut Serums India Private Limited (RSIPL). This rating continues to be an indicative rating and is based on the best available information.

Established in 2008, the Pune-based RSIPL is promoted by Mr. Natha Raut and Mrs. Sunita Natha Raut. The company is engaged in the manufacturing of serums like anti-venom, anti-rabies and anti-tetanus.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
