Acuité has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.15.00 crore bank facilities of Intech Safety Private Limited (ISPL). This rating is now an indicative rating and is based on best available information.

Incorporated in 2003, ISPL was promoted by Mr. Gautam Gupta and family. The company manufactures respiratory masks, protective suits and vests among others as also self-rescuing equipment for the mining industry.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
