Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.5.90 crore bank facilities of Sindhiya Plastic Industries (SPI). This rating is now an indicative rating and is based on best available information.

SPI is a proprietorship concern established in 2010 by Mrs. Sindhiya. The firm is engaged in the manufacturing and trading of plastic chairs in Coimbatore (Tamil Nadu). The day to day operations are managed by Mr. Suresh Sankar (CEO).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
