Acuité has reviewed the long term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the above bank facilities of Ample Textech Private Limited. This rating is now an indicative rating and is based on best available information.

The Kolkata-based ATPL, was established in 2011 by Mr. Radhey Shyam Agarwal and Mr. Vikas Agarwal. The company is engaged in the dying and bleaching of grey fabric on job work basis. Commercial operations commenced in 2013.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
