### Rating Rationale

Acuite has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.00 crore bank facilities of Ample Textech Private Limited (ATPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

### About the Company

The Kolkata-based ATPL, was established in 2011 by Mr. Radhey Shyam Agarwal and Mr. Vikas Agarwal. The company is engaged in the dying and bleaching of grey fabric on a job work basis. Commercial operations commenced in 2013.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
