Rating Rationale

Acuité has reaffirmed its long term rating of ‘**ACUITE D (read as ACUITE D)**’ and the short term rating to ‘**ACUITE D (read as ACUITE D)**’ on the Rs.9.00 crore bank facilities of Shah Paperplast Industries Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

The company is promoted and managed by Mr. Nilesh Shah, Mr. C.C.Shah and Mrs Sheetal Shah. Shah Paperplast Industries Limited exports the Plastic products to USA and Paper products to USA and UK.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
