Rating Rationale

Acuite has reaffirmed the long-term rating to '**ACUITE D (read as ACUITE D)**' and '**ACUITE C (read as ACUITE C)**' on the Rs.7.00 crore bank facilities of Rohini Metals Industries (RMI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Rohini Metals Industries, established as a partnership firm in 2016, recycles lead acid batteries to manufacture lead ingots. The firm is headed by partners, Mr. Prakash Waghdhare and Mrs. Sindhu Waghdhare and also trades in copper, aluminium, brass, MS scrap among others. The manufacturing facility is located at Nagpur with installed capacity of 1500 tons/month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
