Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.7.00 crore bank facilities of Pratik Alloys Private Limited (PAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Surat-based, Pratik Alloys Private Limited (PAPL) incorporated in the year 2005 by Mr. Pratik Vasantbhai Patel. PAPL is engaged into manufacturing of Noble Ferroalloys, Bulk Ferroalloys, Aluminium products and has an installed capacity of 2000 metric tonnes per year. The manufactured product portfolio finds its application in the production of steel alloy. The company procures its key raw material, i.e. molybdenum oxide, Ferro Titanium oxide, to name a few from Jharkhand, Odisha and Andhra Pradesh. PAPL imports aluminium powder from UAE, which is accounted for 30% of its raw material.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
