**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 29.00 crore bank facilities of Rainbow Packaging Private Limited (RPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Rainbow Packaging Private Limited (RPPL) was established in 1986 under the directorship of Mr. Gautam Makwana and Mrs. Niveditha Makwana. The company is engaged in the trading of polymer products and manufacturing of coextruded polyethylene (PE) films near Ahmedabad. The installed capacity stands at around 6,000 metric tonnes per annum (MTPA) for polyethylene film. The day-to-day activities are managed by Mr. Dhavalbhai Parmar and Mrs. Niveditha Makwana).

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
