

Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 6.00 crore bank facilities of Sri Padma Cashew Industries (SPCI). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Sri Padma Cashew Industries (SPCI) is established in 2008 as a proprietorship concern by Mrs. Sulochana Jevander. The firm is engaged in the processing of cashew kernels. It purchases raw material from the local market and also imports from Dubai, South Africa, Indonesia, Tanzania, etc. The firm has an integrated processing plant located in Belthangady, Karnataka with an installed capacity of 50 bags per day with an aggregate capacity of 4000 kilograms.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
