Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.00 crore bank facilities of Make India Polymers House (MIPH). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Chennai based, Make India Polymers House (MIPH) is a proprietorship concern established in April 2016 by Mr S. C. Sekar. The firm is engaged in the trading of poly granules. The proprietor possesses experience of over two decades in the said business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
