**Rating Rationale**

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.80 crore bank facilities of Chandan Trading Corporation on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Chandan Trading Corporation (CTC) is a Bangalore-based partnership firm established in 1982. The firm is a wholesaler and retailer of wires and cables. Chandan Trading Corporation (CTC) is led by partners, Mr Anil Kothari and Mrs Meena Kothari who possess experience of two decades in the industry.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/ borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
