Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 12.00 crore bank facilities of Shell Promoters & Infra Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
