Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 6.75 crore bank facilities of Microbiological Laboratory (ML) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 1977, Microbiological Laboratory (ML) is a proprietorship concern headed by Mr. M. Mani. It provides a wide range of laboratory investigation services necessary for patient care in the discipline of biochemistry, clinical pathology, haematology, immunology and microbiology, among others. With its head office in Coimbatore, it has around 20 branches and 62 collection centres in the states of Tamil Nadu, Karnataka, Andhra Pradesh and Kerala.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
