**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE B' (read as ACUITE B)** and short-term rating of '**ACUITE A4' (read as ACUITE A four)** on the Rs.10.00 Cr bank facilities of Revmax Telecom Infrastructures Private Limited (RTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

RTPL, based at Mumbai, was incorporated in 2004 by Mr. Kaustubh Hirachand Butala. The company is engaged in the business of electronic surveillance systems. These include CCTV, fire alarm systems, access control and intrusion detection systems. The company owns a fully functional OFC (Optical Fiber Communication) network in Mumbai Metropolitan Region (MMR).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
