Acuité has reviewed the long-term rating of '**ACUITE D**' (**read as ACUITE D**) on the Rs. 16.09 crore bank facilities of SRT Educational & Charitable Trust (SECT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

SRT established Madurai Institute of Engineering and Technology (MIET) college in 2009 at Madurai. The institution is AICTE approved and affiliated to Anna University, Chennai. It was founded by Mr. Su. Thirunavukkarasar.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
