Acuité has reviewed the long-term rating of '**ACUITE BB** (read as ACUITE double B) to the Rs. 64.00 crore bank facilities of Sooriya Hospital (SH). This rating is now an indicative rating and is based on best available information.

SH was established in 1991 by Dr. C.P Sreekumar MS (Gen). M.Sc. (Ortho) and his wife, Dr. Sooriyakala Sreekumar, MD. The 200 bed multi-specialty hospital located in Chennai offers a range of healthcare facilities in the fields of orthopaedics, obstetrics, gynaecology and cardiology among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
