Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.6.00 crore bank facilities of Sureshchand Rameshchand (SR). This rating is now an indicative rating and is based on best available information.

SR, an Indore-based firm was established in 1990 as a proprietorship concern and changed to Partnership in 2013. The firm is engaged in processing and trading of pulses such as Masoor Dal, Gram and Peas among others. Current partners of SR are Mr. Dinesh Agarwal, and Mr. Manish Agarwal. The company has its processing facility located at Indore with annual processing capacity of 40000 Quintals.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
