## **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 19.50 crore bank facilities of Shree Hari Om Foods (SHOF) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## **About the Company**

The Haryana-based, Shree Hari Om Foods was established as a partnership firm in 2009 by Mr. Rakesh Kumar, Mr. Lalit Singla, and Mr. Vimal Singla. The firm is engaged in the milling and processing of basmati rice and has installed capacity of 96 MT per day.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
