Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) the Rs.17.00 crore bank facilities of Eastman Mettcast Limited (EML). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Ludhiana-based, EML was incorporated in 2006 by Mr. Jagdeep Singal and his family as Swift Mettcast Limited. In January 2013, the company was taken over by Mr. Subhash Goel and his family. The name was changed to Eastman Mettcast Limited (EML) and they manage the operations of the company. The company is engaged in the business of manufacturing of auto component of heavy vehicle and two-wheelers such as gear-box, clutch braking system and clutch cover, among others. Currently, the promoters of the company are Mr. Gaurav Goel, Mrs. Vinita Subhash and Mr. Karan Goel.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in

the absence of information provided by the issuer/borrower). Acuité endeavoured to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit ratings is based.
