Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs. 35.00 crore bank facilities of Indigo Multifab Private Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Delhi based Indigo Multifab Private Limited, was incorporated in 2001 by Mr. Anil Nagpal and Mr. Ashwini Malhotra, is engaged in the trading of denim fabric. The company purchases fabric from suppliers in Punjab, Gujarat, and Maharashtra and sells the same to clients across states.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

Acuite endeavoured to gather information about the entity/industry from the public domain.
