Acuité has reviewed the long-term rating of '**ACUITE BBB-**' (read as **ACUITE triple B minus**) on the Rs. 6.12 Crore bank facilities of Saroj Gupta Cancer Centre and Research Institute. (SGRI) This rating is now an indicative rating and is based on best available information.

Established in 1973, SGRI is an Association of Person (AOP). It was founded by the Hon. Chief Justice of Calcutta High Court Mr. Shankar Prasad Mitra and Padmashree Dr. Saroj Gupta. It is a super speciality hospital involved in treatment of cancer with a team of around 100 doctors. It has a licensed and operating capacity of around 311 beds with occupancy of around 80 percent.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
