Acuité has downgraded the long term rating to '**ACUITE BB**' (**read as ACUITE double B**) from '**ACUITE BB+**' (**read as ACUITE double B plus**) on the Rs. 6.12 crore bank facilities of Saroj Gupta Cancer & Research Institute(SGRI). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Kolkata based, established in 1973, SGRI is an Association of Person (AOP). It was founded by the Hon. Chief Justice of Calcutta High Court Mr. Shankar Prasad Mitra and Padmashree Dr. Saroj Gupta. It is a super speciality hospital involved in the treatment of cancer with a team of around 100 doctors. It has a licensed and operating capacity of around 311 beds with an occupancy of around 80 percent.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
