### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE Double B minus) on the Rs. 6.12 crore bank facilities of Saroj Gupta Cancer Centre And Research Institute (SGCCRI) on account of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

### **About the Company**

Kolkata based, established in 1973, Saroj Gupta Cancer Centre And Research Institute(SGCCRI) is an Association of Person (AOP). It was founded by the Hon. Chief Justice of Calcutta High Court Mr. Shankar Prasad Mitra and Padmashree Dr. Saroj Gupta. It is a super speciality hospital involved in the treatment of cancer with a team of around 100 doctors. It has a licensed and operating capacity of around 311 beds with an occupancy of around 80 percent.

### **Unsupported Rating**

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
