Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) on the Rs. 10.00 crore bank facilities of Yuvaka Sangha (YS). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Yuvaka Sangha (YS) is an educational society established in 1957, at Bangalore (Karnataka). YS has been providing free coaching to 6 thousand PUC commerce, B.Com and SSLC students every year from its inception in 1957. YS had plans to start a private school in Bangalore. The school was expected to start from June 2017. Students will be accepted from Standard 1 to standard 10. The total cost of the project was Rs.25.19 crore which was funded through Capital funds of Rs.4.00 crore, term loan of Rs.11.00 crore and unsecured loan of Rs.10.19 crore. The promoters, Mr. Chikkaiah and Mr. K. M. Nagaraj, possess extensive experience in the educational sector.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity.
