Acuité has reviewed the short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 15.00 Crore bank facilities of United Teleservices Limited (UTL). This rating is now an indicative rating and is based on best available information.

United Teleservices Limited incorporated in 2011 under the directorship of Mr. Mazibur Biswas, Mr. Dilwar Hossain, Mr. Golam Moinuddim and Mrs. Jasmin Mondal. The company is a national distributor of Gionee mobile handsets across West Bengal, Sikkim and Andaman & Nicobar Islands. Prior to Gionee, the company was distributor of Micromax and Zen phones till 2012. The company has around 45-50 distributors, one central warehouse and 2 sales office.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
