Acuité has downgraded the long term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 15.00 Crore bank facilities of United Teleservices Limited (UTL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

United Teleservices Limited incorporated (UTL) in 2011 under the directorship of Mr. Mazibur Biswas, Mr. Dilwar Hossain, Mr. Golam Moinuddin and Mrs. Jasmin Mondal. The company is a national distributor of Gionee mobile handsets across West Bengal, Sikkim and Andaman & Nicobar Islands. Prior to Gionee, the company was a distributor of Micromax and Zen phones till 2012. The company has around 45-50 distributors, one central warehouse and 2 sales office.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
