Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB-' (read as ACUITE double B minus)** on the Rs. 6.00 Crore bank facilities of Vicky Spinning Mills. This rating is now an indicative rating and is based on best available information.

About the Company

Vicky Spinning Mills (VSM) was established in the year 1995 as a proprietorship concern in Haryana. However, on 1st April 2014, the constitution was changed into a partnership concern. The firm is promoted by Mr. Rajiv Garg and Mrs. Reena Garg. The firm is engaged in the manufacturing of cotton yarn.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
