Acuité has reviewed the long-term rating of '**ACUITE C**' (read as **ACUITE C**) on the Rs.15.00 crore bank facilities of Select Exim (SE). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SE, established in 2011, is a Chennai-based partnership firm promoted by Mr. Azam Khan and his brother, Mr. Mohammed Salaieh A. The firm procures processed steel from SMPC Industries to manufacture dish antennas for Direct to Home (DTH) service providers. It caters to Bharati Airtel and TATA Sky.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
