Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short term rating of 'ACUITE D' (read as ACUITE Do) in the Rs. 11.00 crore bank facilities of Raj Foods Industries. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

The Raipur-based, Raj Foods Industries (RFI) is a proprietorship firm established in 2000. The firm is promoted by Mr. Tikam Das Sadhwani (Proprietor). The firm is engaged in the processing of rice. The manufacturing unit is located in Rajim (Chhattisgarh) with the installed capacity of 57600 metric tons of rice per annum.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
