Acuité has downgraded the long term rating to '**ACUITE BB**' (**read as ACUITE Double B**) from '**ACUITE BB+**' (**read as ACUITE Double B Plus**) on the Rs.36.00 crore bank facilities of Kedia Brothers (KB). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 1993, Kedia Enterprise (KE) is managed by Mr. Manoj Kumar Kedia. Mr Pawan Kumar Kedia, father of Mr Manoj Kumar got into the business of cotton trading in the year 1971 with the company name Bhawani Textiles.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
