Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (**read as ACUITE B Plus**) and the short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 5.25 crore bank facilities of Marvels. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Karnataka-based, Marvels was incorporated in 2007 as a partnership firm by Mr. Pramod Kumar, Mrs. Kiran, Mrs. Priti, Mr. Abhishek and Mr. Amol Kumar. The firm is engaged in the business of processing and trading of raw cotton, cottonseed oils and cakes, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
