Acuité has downgraded the long-term rating of '**ACUITE BB-**' (**read as ACUITE Double B minus**) from '**ACUITE BB** (**read as ACUITE double B**)' on the Rs. 7.01 crore bank facilities of MKS Enterprises (MKSE). This rating continues to be an indicative rating and is based on the best available information.

Incorporated in 2014, MKS Enterprises (MKSE) was promoted by Mr. Shrikant Bhangdiya. The firm is engaged in the manufacturing of high-density poly ethylene (HDPE) and PP (Poly Propylene) woven bags and fabrics (laminated/unlaminated) at its plant at Nagpur (Maharashtra). These sacks/bags are used in cement, sugar and construction industries.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
