Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 9.00 crore bank facilities of Sri Lakshmi Ganapathi Engineering Works (SLGEW) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sri Lakshmi Ganapathi Engineering Works (SLGEW) was established in 1977 by Mr. K. Subramanyam. The firm is engaged in the manufacturing of domestic and agricultural pumps with an installed capacity of 4000000 pump sets per annum. The manufacturing facility is located at Guntur district, Andhra Pradesh.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
