Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D)on the Rs. 20.00 Crore bank facilities of Purvi Metals Private Limited (PMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Purvi Metals Private Limited (PMPL), incorporated in 2011, is a Mumbai-based company promoted by Mr. Brijesh Singh and Mr. Rangabahadur Singh. The company is engaged in the trading of steel coils. The company buys steel coils from manufacturers in bulk and sells the same across India.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
