Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) and the short term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 12.00 crore bank facilities of Ammen Mills (AM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established in 1979, Tamil Nadu based AM is a partnership firm engaged in the manufacturing of knitted garments such as Tshirts, Polo shirts and sweatshirts, among others. The partners include Mr. K. Mohanageetha, Mr. K.T. Karunamurthy and Mr. K. Rajeswari.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
