Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 12.00 crore bank facilities of Ammen Mills (AM). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

About the Company

Established in 1979, Tamil Nadu based Ammen Mills AM is a partnership firm engaged in the manufacturing of knitted garments such as T-shirts, Polo shirts and sweatshirts, among others. The partners include Mr. K. Mohanageetha, Mr. K.T. Karunamurthy and Mr. K. Rajeswari.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
