Acuité has reviewed the long-term rating of '**ACUITE BBB-**' (read as **ACUITE Triple B minus**) and short term rating of **ACUITE A3+** (read as **ACUITE A three plus**) on the Rs. 48.00 Crore bank facilities of Radheshyam Agrawal (RA). This rating is now an indicative rating and is based on best available information.

RA is a Chhattisgarh based partnership firm promoted Mr. Radheshyam Agrawal, Mr. Sanjay Kumar Agrawal and Mr. Bajrang Lal Agrawal. The firm is engaged as civil contractor for roads, bridges, tunnels, canal irrigation and foundation for PWD (Public Work Department), WRD (Water Resources Department) and National Highway Authority of India (NHAI).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
