**Rating Rationale**

Acuité has downgraded the long-term rating to '**ACUITE BB**' (**read as ACUITE double B**) from '**ACUITE BBB-**' (**read as ACUITE triple B minus**) and the short-term rating to '**ACUITE A4+**' (**read as ACUITE A four plus**) from '**ACUITE A3+**' (**read as ACUITE A three plus**) on the Rs.48.00 crore bank facilities of Radheshyam Agrawal (RA). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

RA is a Chhattisgarh based partnership firm promoted Mr. Radheyshyam Agrawal, Mr. Sanjay Kumar Agrawal and Mr. Bajrang Lal Agrawal. The firm is engaged as civil contractor for roads, bridges, tunnels, canal irrigation and foundation for PWD (Public Work Department), WRD (Water Resources Department) and National Highway Authority of India (NHAI).

**Non-cooperation by the issuer/borrower:** Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
