Acuite has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4 (read as ACUITE A four)**' on the Rs. 9.00 Crore bank facilities of S Satish Class 1A Contractor (SSCC). This rating is now an indicative rating and is based on best available information.

Established in 1990, SSCC is a Bangalore-based proprietorship concern promoted by Mr. S. Satish. The proprietor of the firm has around a decade of experience in civil contractor business. The firm is engaged in construction of asphalt roads. SSCC is a Class 1A contractor and undertakes projects for Bruhat Bengaluru Mahanagara Palike (BBMP).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
